The Fishery Management Plan (FMP) for Spiny Lobster in the Gulf of Mexico and South Atlantic was implemented July 2, 1982 (47 FR 29203). The FMP largely extended Florida ' s rules regulating the fishery to the exclusive economic zone (EEZ) throughout the range of the fishery, i.e. North Carolina to Texas.

The Spiny Lobster FMP, implemented in July, 1982, largely complemented the State's management regime and provided protection for the fishery throughout its range. The FMP provided management authority only for that part of the fishery operating in the EEZ; the fishery within state waters remained under State authority.
